Best of Show: \$1,000 cash prize, plus a one person exhibit at a mutually agreed upon date in 2012 or early 2013. Additional prizes and awards to be announced.

Opening reception: Sunday April 22nd, 2- 4 p.m. Awards 3 p.m.

Juror: Susan Cross, Curator, MASS MoCA.

Cross has worked with a range of emerging and established international artists. She recently organized *The Workers*, an exhibition which examines contemporary conditions of labor through the eyes of twenty five international artists and filmmakers.

Before moving to North Adams, Cross was a curator at the Solomon R. Guggenheim Museum. She received a B.A. in Art History from the University of Virginia. and has a Masters from the Williams College Graduate Program, History of Art.

Categories for original work: Painting, drawing, mixed media, sculpture, photography, ceramics, printmaking, and collage.

Giclees reproductions of original works are not eligible.

ELIGIBILITY:

Artist must reside in Connecticut, Maine, Massachusetts, New Hampshire, New York, Rhode Island or Vermont.

▪ Work must have been created during the last 2 calendar years and not previously exhibited in a WHAL juried show.

▪ Work must be suitably framed and wired for hanging. ▪ Wrapped canvases must have no staples showing. ▪

Framed dimensions may not exceed 50 inches on longest side. ▪ Work on paper must be under glass or Plexiglas.

▪ Sculptures may not weigh more than 50 lbs. ▪ Work will be accepted in person (hand delivered) or by CD-Rom. ▪

Pre-Registration Form must be completely filled out, signed and received by Thursday March 29th, 12 noon.

ENTRY FEES/SUBMISSIONS:

TO ENTER: Entries may be submitted digitally or hand-delivered. **All entries must be pre-registered by mail..**

Please complete and return the Pre-Registration form with payment to 37 Buena Vista Road, West Hartford, CT by **Thursday March 29th.**

If you missed the pre-registration date, you may still enter but will be charged an additional \$15 late fee.

Fee for EACH ENTRY: \$20 non-members, \$15 members. ▪ Up to four artworks may be submitted. ▪ Make checks payable to West Hartford Art League. Fees are non-refundable.

DIGITAL ENTRIES:

You must include your CD with your Pre-Registration Form and fee. Full view digital images must be in JPEG format with 200 dpi resolution. ▪ CD must be PC compatible. Unreadable CDs will be disqualified. ▪ Files should be named as follows: first initial, last name, abbreviated title, number [1-4]. ▪ Label your CD (hand print) with name, phone number, e-mail address, and number of images. ▪ Images incorrectly identified or mislabeled will be disqualified. ▪ Digital image title **must** match the title on the entry form. ▪ CDs will not be returned.

(RECEIVING OF) HAND DELIVERED ENTRIES:

Work will be received on **Wednesday, April 4th from 1-3 p.m. and 6- 8 p.m.** at 37 Buena Vista Road, West Hartford, CT. ▪ Artwork WILL NOT be accepted before or after the dates noted.

OPENING: The exhibit runs April 22 - June 4. Opening reception will be held Sunday April 22, 2012 from 2-4 p.m. Awards will be announced at 3 p.m.

AWARDS: Best of Show: \$1,000 cash plus a one person exhibit at the Art League. Additional cash awards and prizes.

CLOSE OF SHOW:

Work may not be removed before the close of the gallery the last day of the show.

Work not picked up by June 1 is left at owners' risk and could be subject to storage fees of \$10 per day.

SALES: All artwork must be for sale. A 30% commission is taken on all sales.

LIABILITY: Every reasonable care will be taken in the handling and storage of the works submitted; however West Hartford Art League is not responsible for loss or damage. Accepted work will be insured at 70% of artist's retail price.

CALENDAR:

Pre-Registration Form and entry fees must be received at WHAL, 37 Buena Vista Road, West Hartford, 06107, by Thursday March 29, 2012 noon.

Digital entries due-in office: Friday April 13, 2012 noon.

Receiving of hand delivered artwork: Wednesday April 4, 2012 from 1-3 p.m. and 6-8 p.m..

Notification of acceptance will be posted at westhartfordart.org: Monday April 9, 2012 by noon.

Accepted digital work must be on premises (shipped or dropped off) by Friday April 13, 2012 at noon. Ship work to 37 Buena Vista Rd, West Hartford. 06107. Attn: CT+6. Artists are responsible for return shipping at end of exhibit.

Pick up of unaccepted work: Sunday April 8, 2012 from 12-2 p.m. Clubhouse Gallery, 37 Buena Vista Road, West Hartford, CT. Identification required for pick-up.

Opening reception: Sunday April 22, 2-4 p.m. Awards presented at 3 p.m

Pick up of exhibited work: Sunday June 3, 2012 from 4 - 5 p.m. and Monday June 4, 2012 from 10 - 11 a.m.

Work may not be removed before the close of gallery the last day of show. Work not picked up by date is left at owners' risk. Identification required for pick-up.
