A Juried Exhibition open to Members of the West Hartford Art League

ELIGIBILITY:

All members are eligible to enter. Work must have been created during the last two calendar years and not previously exhibited in a juried WHAL show. Work must be suitably framed and wired for hanging. Framed dimensions may not exceed 50 inches on the longest side. Work on paper must be under glass or Plexiglass. Sculptures may not weigh more than 50 lbs.

For this exhibit, we will accept work that is hand delivered only. (no digital entries)

1. Pre-register: Please fill out the pre-registration form and send it to 37 Buena Vista Road, West Hartford, CT, 06107 on or before **Friday, January 27, 2012**. This is not a postmark date. Payment must be included with form. If you miss the pre-registration date, you may still enter work but will be charged an additional \$10 late fee.

2. Fee for each entry: \$10. Up to four artworks may be submitted for \$40. Limit: two acceptances. Make checks payable to West Hartford Art League. Fees are non-refundable.

3. Drop off your work: Receiving: Friday, February 3, 1-3 and Saturday, February 4, 1-3 p.m., Clubhouse Gallery. Due to space limitations, Artwork cannot be accepted before the date noted.

4. Check our website: Accepted work will be listed on our website at www.westhartfordart.org on Tuesday February 7.

5. Pick-up of unaccepted work: Work not accepted must be picked up Saturday, February 11 from 1-3 p.m. in the Clubhouse Gallery. Identification is required for pick-up.

6. Opening reception and awards: Sunday, February 12, 2-4 p.m. Awards: 3 p.m. Clubhouse Gallery

7. CLOSE OF SHOW: No work may not be removed before 4:00 p.m. the last day of the show.

8. ACCEPTED PICK-UP: Sunday, March 4th, 4-5 p.m. or Monday March 5th, 9-10 a.m.

Work not picked up by Monday, March 5, 2012 is left at the owner's risk and is no longer the responsibility of the West Hartford Art League..

SALES: All artwork must be for sale. A 30 percent commission is taken on all sales.
